THE

POWER OF CARING

Richards, Layton & Finger ("RLF") attorneys and staff continued to undertake probono engagements in large numbers during FY 2022, with 74% of the firm's attorneys participating in probono and community service ("PBCS") projects. During the year:

- RLF attorneys and staff logged more than 5,100 hours on PBCS matters.
- 83% of the firm's associates recorded PBCS time during the year.
- 62% of our directors spent time on PBCS matters.
- 89% of our counsel participated in PBCS.
- Our staff provided administrative support on nearly all PBCS matters.
- The firm opened 41 new PBCS matters during FY 2022.



OUR INITIATIVES

Various initiatives were continued during FY 2022. The Pro Bono and Community Service Committee continues to advance the purposes of the firm's PBCS program, including:

- Giving back to the community we serve
- Enhancing the firm's reputation and the RLF brand
- Associate recruitment, development, and retention
- Community involvement and relationship building with individuals, public officials, non-profit organizations, and institutions throughout Delaware and beyond
- Relationship building within the firm
- Client development
- Professional development training for all attorneys

One of the firm's largest pro bono projects has been its ongoing work on behalf of **Central Baptist Community Development Corporation** ("CBCDC"). Under the leadership of retired director **Robert Krapf** and **Mark Kurtz**, the firm dedicated over 150 hours in the past year representing **CBCDC** in connection with its Eastside Rising initiative, an effort to revitalize Wilmington's Eastside community through housing improvement, workforce development, and economic empowerment. Our efforts included negotiating a joint venture agreement; reviewing and preparing memoranda of understanding and contracts involving workforce training programs, low-income housing rehabilitation,

and promotion of home ownership; advising on loan financing transactions; and advising on various matters of Delaware law, including employment law matters. This initiative has improved both the infrastructure and the quality of life in a significant section of our community. During the past year, Jennifer Jauffret, Robert Krapf, Mark Kurtz, Jake Crosetto, R. Parker Havis, Ellen Rosaio, and Susan Stewart, among others, contributed their time to this project.





PRO BONO PROGRAMS

The Federal Civil Panel. The firm participates in the Federal Civil Panel under the auspices of the U.S. District Court for the District of Delaware. Through this program, the firm receives referrals from the Federal District Court of cases filed by indigent plaintiffs. The cases typically involve alleged civil rights violations. Through this program, it is intended that attorneys will have the opportunity to first-chair active litigation matters in the Delaware District Court. The Federal Civil Panel Team is led by **Kelly Farnan**.

The Non-Profit Team. This team's goal is assisting non-profit organizations with various legal projects, including drafting incorporation documents, answering legal questions, and serving on or counseling non-profit boards. It is a popular team among the firm's attorneys, with 41 members. The Non-Profit Team is led by **Elisa Erlenbach Maas** and **John Mark Zeberkiewicz**.

In FY 2022, the Non-Profit Team hosted a variety of presentations directed to attorneys who serve or are interested in serving on a non-profit board of directors. On October 26, 2021, **John Mark Zeberkiewicz** presented an insightful in-house CLE on board governance. On February 24, 2022, the Non-Profit Team hosted a virtual CLE with **Pamela Leland, PhD, Chief Learning Officer of the Delaware Alliance for Nonprofit Advancement ("DANA")**, titled *From Connection to Collection: The Many Ways Board Members Can Help Raise Funds*.

On May 9, 2022, the Non-Profit Team hosted the CLE, *First Time Non-Profit Board Experiences*, featuring panelists **Dorronda Bordley**, Director, TeenSHARP; **Ally Ewing**, Director and Member of the Executive Committee, Christina Cultural Arts Center; **Richard Facciolo**, Director, Music School of Delaware; **Nicole Henry**, Director, Catholic Charities Diocese of Wilmington; **Brian Mammarella**, Director, YMCA of Delaware, Central Branch; and **Kate Mowery**, Founder and Vice President, International FoxP1 Foundation, among others. This discussion provided insights into the expectations, benefits, and opportunities presented to those who volunteer for leadership positions on non-profit boards, and highlighted the various missions and causes being championed by members of the firm.

The Office of the Child Advocate Team. The Office of the Child Advocate ("OCA") Team is comprised of 31 attorneys and led by **Jennifer Jauffret**. Over the course of the year, 12 RLF attorneys represented 15 children in abuse and neglect proceedings, providing an important service to the court and the children as well as valuable litigation and counseling experiences for our lawyers. Our attorneys dedicated over 235 hours to serving as child attorneys in FY 2022. Since the inception of this program over 20 years ago, RLF attorneys have dedicated over 14,100 hours to the representation of 264 children in these Family Court proceedings.

PRO BONO PROGRAMS

On November 16, 2021, **Jennifer Jauffret**, **OCA Team leader**, **Cory Kandestin**, **Greg Ladner**, and **Claire Love** led a presentation for the firm's attorneys highlighting their involvement over the years with the Office of the Child Advocate and the positive personal and professional experiences gained from serving as child attorneys.

Nicole Henry and **Melissa Lagoumis** served as guardians *ad litem* to three boys who have been successfully placed in the guardianship of their maternal aunt. Through meetings with the children and their respective guardians, as well as appearances at Family Court hearings and conferences, Nicole and Melissa ensured that the children's best interests were recognized and respected.

Claire Love, Kinsey Lenehan, and Robert Troiano worked with the Department of Services for Children, Youth & Their Families (DSCYF) to find a home for an infant born to teen parents who had extensive histories with the Division of Family Services ("DFS") and were unable to care for the child. Although efforts were made to place the child with family members, he ultimately found a home with a loving and nurturing foster family. The court recently ordered termination of the parental rights of his birth parents, thus freeing him for adoption.

Edmond Kim, among others, under the supervision of **Amanda Steele**, worked with DFS to find a suitable home for an infant who was born substance exposed and was abandoned by his mother at the hospital following his birth; the identity of the father was unknown.

Cory Kandestin, **Edmond Kim**, and **Rachel Sharp** are representing a baby boy whose mother cannot care for him due to substance abuse and lack of stable housing; paternity has not been established.

Protection from Abuse Team. The Protection from Abuse ("PFA") Team consists of 20 attorneys who assist **Delaware Volunteer Legal Services, Inc. ("DVLS")** with obtaining Protection from Abuse Orders for victims of domestic violence. The PFA Team dedicates its time to handling protection from abuse proceedings, including representing victims at virtual hearings throughout the COVID-19 shutdown. In FY 2022, **Sara Thompson** was named as the **PFA Team leader**.

PRO BONO PROGRAMS

On May 19, 2022, the PFA Team hosted *How to Handle a Protection from Abuse Case*, a CLE presented by **DVLS attorneys Tom McDonough** and **Jacki Chacona**. On June 9, the PFA Team hosted a "Lunch and Learn" CLE with the summer associates, featuring **Family Court Commissioners Danielle Blount and Para Wolcott**, who presented the CLE, *Preparing for a Protection from Abuse Hearing: Perspectives from the Bench*.

Tianshu (Allie) Ji, Melissa Lagoumis, and **Sandy Xu** teamed up to serve as first-time volunteers on three PFA cases with the guidance and support of DVLS attorneys. All three matters involved representing women in prosecuting their PFA petitions against their spouses or significant others from physical, verbal, and emotional abuse.

Wills Team. This team of 28 attorneys is headed by **Monica Ayres** and offers services, through DVLS, to indigent clients with estate planning and related needs. In addition to the preparation of wills, the team offers various other estate-planning options, such as the creation of health-care directives, durable powers of attorney, HIPAA authorizations, and planning documents for the disposition of last remains. This pro bono offering affords valuable one-on-one counseling opportunities for our lawyers.

Co-Counsel Project. Private law firms are asked to provide pro bono attorneys to partner with the Public Defender's Office on serious felony cases. Our attorneys serve as second chair and are expected to research, prepare, and argue motions, such as suppression of evidence. The firm has 11 attorneys on this team.

Unaccompanied Minors. The firm participates in training attorneys to represent unaccompanied minors coming to Delaware. **Marcos Ramos** and **Marisa Terranova Fissel** lead this team, supervising associates as they receive requests for representation in Family Court guardianship and immigration cases.

Lex Mundi Pro Bono Foundation. RLF is the Delaware member firm of Lex Mundi, which is comprised of more than 150 member law firms spanning 100 countries across the globe, and the Lex Mundi Pro Bono Foundation. Through the Lex Mundi Pro Bono Foundation, the firm's attorneys provide legal support to global organizations focused on societal changes that will improve lives and communities around the world.



AD HOC PROJECTS

All firm attorneys are invited to suggest and participate in pro bono and community service projects that reflect their interests. During FY 2022, RLF attorneys were engaged in a variety of ad hoc PBCS projects, including serving on boards and committees, setting up new non-profit organizations, researching issues of law for non-profits, and organizing fundraising efforts to promote various causes. Below are some of the more significant ad hoc PBCS projects in FY 2022.

In 2022, RLF real estate attorneys Sara THE MINISTRY OF CARING INC. Wagner, R. Parker Havis, Philip Micha, and paralegal Susan Stewart, helped the Ministry of Caring, Inc. in a number of acquisitions facilitated by generous donors in the Wilmington community. The Ministry has added a "secret garden" to its childcare center, and is also in in the process of obtaining an



unused property for a yet-to-be determined purpose. We are assisting the Ministry of Caring to obtain HUD and other financing for its Villa Maria project, which will provide homes to low- and moderate-income seniors. Brother Ronald Giannone, the Ministry's founder and executive director, said, "We are grateful to Sara Wagner [an attorney who has served 10 years on the Sacred Heart Village II board of directors and is now its vice president] and her colleagues at Richards, Layton & Finger for their willingness to do the legal work required so that we can go to the settlement table with HUD and DSHA."

- Firm attorneys Russell Silberglied and Nicole Pedi, along with summer associates Ashly Riches and Naseeba Saeed and paralegals Ann Jerominski, Lynzy McGee, and Rebecca Speaker, among others, represented a nearly destitute musician and part-time school band teacher in the collection from a local guarantor of his settlement of a copyright infringement lawsuit stemming from over 300 of his written music lessons being used to make mobile apps. After RLF filed a complaint in federal court and initiated litigation activities, the defendant paid the pro bono client 100% of what was owed, not including any interest, attorneys' fees, or punitive damages.
- **Professor Mary Dozier**, a psychology professor at the University of Delaware, developed an evidence-based behavioral intervention protocol called Attachment and Biobehavioral Catch-up (ABC) to enhance parental responsiveness among parents of vulnerable infants. At UD, Prof. Dozier administered ABC protocols and developed a staff capable of training parents and care providers to administer the ABC intervention to infants around the country. John Mark Zeberkiewicz and Brian Mammarella assisted Prof. Dozier by forming a non-profit Delaware corporation, ABC Parenting Institute, through which Prof. Dozier and her team continue their good works.

AD HOC PROJECTS

Russell Silberglied is a member of the board of directors of The Mariano Rivera Public Foundation ("MRPF") and serves as its corporate secretary and counsel. In the last year, he has regularly provided legal advice on contracts, licenses, and other matters. Additionally, Russ solicits the help of other RLF attorneys on MRPF matters. For example, Jason Rawnsley, Jennifer Siew, and RLF summer associates Jessica



Blau and **Gabrielle Rossi** represented MRPF in registering and enforcing the foundation's copyrights and trademarks on its signature fundraiser t-shirts against a series of infringers. Additionally, **Sara Wagner** has assisted Russ in his advice to MRPF in connection with real estate and state grant issues. The firm contributed nearly 200 hours to MRPF in the past fiscal year.

Under the supervision of directors Kevin Gross and Sara Wagner, summer associates Ryan Brady, Naseeba Saeed, and Alison Sayers researched various legal issues on behalf of the Legal Services Corporation of Delaware, Inc. The pro bono assistance included summarizing CARES Act rules, deadlines, and options; reviewing options for the pro se administration of estates where the client is heir to the property in foreclosure; and researching the issue of whether an attorney can be hired by a mortgage company/lender and sworn in as the executor of an estate for the purpose of initiating foreclosure proceedings.



Phil Micha assisted Delta Outreach & Education Center, Inc. with the sale of a property in Wilmington. He helped negotiate a purchase and sale agreement, advised the organization on environmental issues regarding the contaminated property that was subject to a Brownfield Development Agreement, including assignment of the agreement, and assisted with the real estate closing. Delta Outreach & Education Center provides educational and social services, cultural enrichment, and personal developmental skills primarily for adolescent girls.



AD HOC PROJECTS

Edmond Kim assisted the International FOXP1 Foundation, a non-profit aimed at building a global community that empowers and supports families and individuals with FOXP1 syndrome, by reviewing its governing documents and drafting documents in support of its operations. He also researched and summarized the requirements of Pennsylvania's Solicitation of Funds for Charitable Purposes Act in preparation for the International FOXP1 Foundation to raise funds for its cause. Katharine Lester Mowery, who is a founder and vice president of the foundation's board of directors, was the supervising director.



- Mark Purpura, Stephanie Norman, Zach Kmetz, and summer associate AJ Dillione assisted Inevitable Foundation, an organization breaking down the barriers that keep disabled screenwriters from reaching their potential. The team helped Inevitable Foundation create an LLC through which individuals who receive fellowships or are otherwise involved in the organization's activities can access insurance and other benefits offered by the organization, given the significant obstacles to healthcare equity and justice for disabled freelancers.
- The firm is a pro bono partner for the Second Chance Employment Collaborative, launched in 2021 by JPMorgan Chase and Wilmington Alliance, in partnership with Delaware Volunteer Legal Services, Wilmington HOPE Commission, Delaware Center for Justice, and Project New Start. Firm attorneys assisted the participants of the Second Chance Employment Collaborative with the expungement process and the filing of FDIC waivers in order to pursue employment in the financial, healthcare, and IT sectors. Associates Dorronda Bordley and Caroline McDonough served as pro bono attorneys for the Second Chances Record and Expungement Fair on April 28, 2022. Overall, 500 individuals received services at this event, and the volunteer attorneys alone assisted 68 individuals.

COMMUNITY SERVICE PROGRAMS

The Bancroft School Mentoring Team. The firm has a longstanding relationship with **Big Brothers Big Sisters of Delaware's Mentoring Program**. For years firm attorneys and staff, individually and in pairs, have served as mentors to children in kindergarten through fifth grade at **The Bancroft School**. Unfortunately, due to COVID-19 the mentoring program was delayed and then eventually moved to a virtual setting in the spring of 2021. The members of the team look forward to returning as in-person mentors at the school when it is safe to do so.

Leadership Council on Legal Diversity's Success in Law School Mentoring Program. In 2020, the firm began participating in the LCLD's Success in Law School Mentoring Program, which matches attorneys at LCLD member organizations with 1L students of diverse backgrounds. The Mentoring Program provides guidance and support to diverse law students during their first year of law school and beyond. The firm's 2021-22 LCLD mentors were Doneene Damon, Samuel Gray, Kevin Gross, Maya Jackson, Tianshu (Allie) Ji, Angela Lam, Caroline McDonough, Kate Mowery, Danielle Andrisani Nowaczyk, Nicole Pedi, Matthew Schwalm, and Cassandra Thompson, among others.



The Emmanuel Dining Room Teams. RLF lawyers and staff are dedicated to continuing the firm's longstanding community outreach effort of serving meals each month to the homeless and working poor within our community at the Ministry of Caring's Emmanuel Dining Room. As of March 2020, the firm's 9 Emmanuel Dining Room teams included over 70 volunteers who traditionally served a total of 36 annual lunches at the Emmanuel Dining Room. Due to COVID-19, the Emmanuel Dining Rooms could no longer allow volunteers on site; as such, the firm made periodic donations to the Emmanuel Dining Room and continues to make direct contributions to its annual TurkeyThon fundraiser. In August of 2022, the firm's volunteers returned to Emmanuel Dining Room with 4 new EDR teams, led by Albert Feeley, Jr., R. Parker Havis, Kathy Howard, and Melissa Lennon. Our additional EDR volunteers are Daniel Barrow, Avery Benesch, Mari Boyle, Ryan Brady, Morgan Harrison, Nicole Henry, Ken Jackman, Bernie Kelley, Kevin Kidwell, Linda Kish, Greg Ladner, Kinsey Lenehan, Sara Metzler, Katharine Lester Mowery, Grace Myers, Ismat Nawaz, Joshua Novak, Danielle Andrisani Nowaczyk, Katie Reese, Naseeba Saeed, Alison Sayers, Griffin Schoenbaum, Stacey Smith, Marisa Terranova Fissel, and Nancy Whan Tong.

MARTIN LUTHER KING DAY OF SERVICE

On Martin Luther King Day, the firm hosts a Day of Service to commemorate the memory of Dr. Martin Luther King Jr. and to promote outreach to those in need in our community. The firm's 2022 MLK Day of Service was again virtual, but we still made an impact. Members of the firm donated coats and other cold weather items to the **Ministry of Caring's "Operation Overcoat"** fundraiser, and we provided hot to-go lunches for 400 homeless and at-risk people who were served at **Emmanuel Dining Rooms East and West** on Martin Luther King Day. The firm held a virtual fundraiser and donated \$15,487 to **The WRK Group's** three entities (REACH Riverside, The Warehouse, and Kingswood Community Center), and we hosted a virtual MLK Day presentation featuring **Logan Herring, CEO of The WRK Group**.



Throughout FY 2022, the firm continued to support **Eisenberg Elementary School's food pantry**, which supplies students and their families with much-needed groceries and household items throughout the year. Eisenberg Elementary School serves over 500 children, many of whom are ethnically diverse and either homeless, living in poverty, or at risk. Unable to host an in-person collection for the Eisenberg Elementary School's Food Pantry due to the pandemic, the firm donated a record \$14,475 to the school's food pantry in FY 2021. **Brigitte Fresco** and retired CFO **Ed Pierce** advocated for and supported this project. Eisenberg Elementary is truly grateful for the firm's annual donations and the crucial role they play in servicing the basic needs of their students' families.

MARTIN LUTHER KING DAY OF SERVICE

As part of our MLK Day of Service, individuals at the firm partnered with the **National Museum of African American History and Culture** and the **Smithsonian Institution's Transcription Center** to volunteer on their digital transcription project, helping to digitally transcribe more than 1.5 million handwritten pages found within the Freedmen's Bureau Records detailing enslaved people's journey to freedom following the Civil War. **Daniel Barrow**, **Jordan Cramer**, **Laura Dietrich**, **Cayla Dupuis**, **Chandler Elliott-Fehle**, **Samuel Gray**, **Maya Jackson**, **Kevin Kidwell**, **Edmond Kim**, **Angela Lam**, **Emily Mathews**, **Christine Morabito**, **Frank Sun**, **Sara Thompson**, and **Sandy Xu**, among others, together contributed over 65 hours to this national service effort. Working together on such service projects gives attorneys and staff who may not otherwise have regular contact the opportunity to get to know one another on a personal level while giving back to the local community.

In 2020, the firm initiated a new tradition of a **Class Pro Bono Project**, a community service effort to be shared by all future entering classes. On June 14, the new 2021-22 associates spent 3½ hours volunteering with Waggies' staff to make dog treats. **Waggies by Maggie & Friends** is a non-profit dog treat company whose mission is to employ persons with intellectual disabilities. ANNUAL PRO BONO CELEBRATION

On June 8, the firm hosted its annual pro bono celebration to recognize the outstanding contributions and commitment of our attorneys and staff to our community. We embraced our ability to come together in person for the first time in three years to celebrate our shared accomplishments this past year and to renew our commitment to helping our community and those in need. **Doneene Damon** spoke of the firm's longstanding commitment to helping others and highlighted the value the firm places on pro bono and community service efforts.
