Our firm remains focused on broadening and deepening our D&I strategy.

The strategy includes (1) ensuring we cast a wide net to increase our opportunity to recruit qualified law students; (2) creating a professional development plan to improve retention and upward mobility within the firm; (3) creating a pipeline of diverse talent throughout our firm; and (4) working with the broader legal community to increase expertise in the Delaware bar. But within all of this, we continue to prioritize the "I" in our D&I strategy.

The "I" in our D&I strategy is our driver and the metric we measure. Inclusion is foundational to an effective D&I strategy. At its core, inclusion is about removing barriers and giving equal access and opportunities to all. An inclusive workplace is one in which the working culture and environment recognizes, appreciates, and effectively utilizes the talents, skills, and perspectives of every employee

to achieve the organization's objectives and mission, and, in doing so, connects each employee to the organization. In essence, we prioritize a culture of belonging. COMMUNITY LEGAL AID & ADVOCACY



PRO BONO TEAMS AND IMPACT

ATTORNEY AD LITEM TEAM

In 2022, at the request of **Chancellor Kathaleen McCormick**, the firm started an Attorney *ad Litem* pro bono team to serve in adult guardianship hearings in the Delaware Court of Chancery through **Delaware Volunteer Legal Services (DVLS)**. **Rob Burns** and **Chad Shandler** are co-chairs of this eleven-member team. **Rob Burns**, **Susan Hannigan Cohen**, and **Nicole Henry** have continually volunteered to represent clients in these matters in 2025, and many other RLF attorneys have completed the required training.

FEDERAL CIVIL PANEL TEAM

Led by **Kelly Farnan**, this team receives civil rights cases referred by the U.S. District Court for the District of Delaware and affords attorneys significant litigation experiences on behalf of indigent plaintiffs.

FAMILY COURT APPOINTMENTS

Richards Layton attorneys, including **Danielle Bell**, **Brock Czeschin**, **Zachary Greer**, **Greg Ladner**, **Alison Mitchell**, **Quamaine Montgomery**, **Kevin Rodriguez**, and **Kaitlyn Zavatsky**, among others, volunteered to handle Family Court appointments assigned to the firm in the past year, with **Brock Czeschin**, **Travis Hunter** and **Greg Ladner** serving as supervisors. In June, **Quamaine Montgomery** and **Greg Ladner**, among others, hosted a mediation at the firm and reached a settlement agreement on the custody issue in their matter.

WILLS TEAM

The firm's Wills Team, headed by **Monica Ayres** with thirty-two attorneys, volunteers through DVLS to draft wills, healthcare directives, powers of attorney, and other related documents on behalf of Delaware's indigent seniors. During National Pro Bono Week and the Delaware State Bar Association's (DSBA) Dr. Martin Luther King, Jr. Day of Service, firm attorneys offered estate planning assistance to indigent seniors participating in "Wills for Seniors" events at the Elsmere Fire Hall, Police Athletic League, and Delaware Law School. On October 26, **Andrew Jung**, **Quamaine Montgomery**, and **Andrew Rosen** volunteered with DVLS at the Wills for Seniors event at the Delaware Law School. **Danielle (Dani) Bell** and **Benjamin Allen** handled their first DVLS Wills matter in 2025 under the supervision of **W. Donald Sparks, II**.

PROTECTION FROM ABUSE (PFA) TEAM

This fourteen-attorney team assists DVLS in obtaining protection from abuse orders for victims of domestic violence and hosts specialized CLE trainings throughout the year. On October 9, **Jacki Chacona, Esq., Deputy Director of DVLS**, and **Giovanna Crozier-Fitzgerald, Esq., Holland Fellow at DVLS**, presented the CLE, *How to Handle a PFA Hearing*. **Huiqi (Vicky) Liu** and **Sandy Xu**, among others, have volunteered to handle Protection from Abuse matters in the past year, including ones that involved overcoming communication barriers with native-Mandarin-speaking victims.

CO-COUNSEL PROJECT

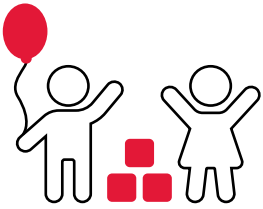

INNOCENCE PROJECT DELAWARE

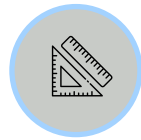
FOOD SECURITY

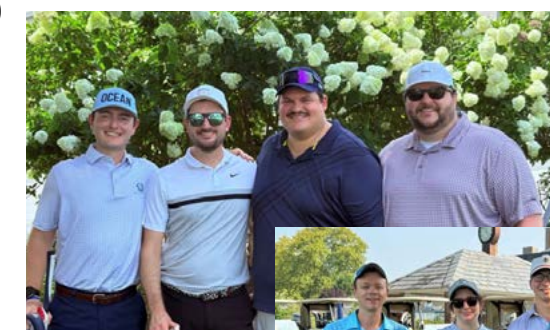

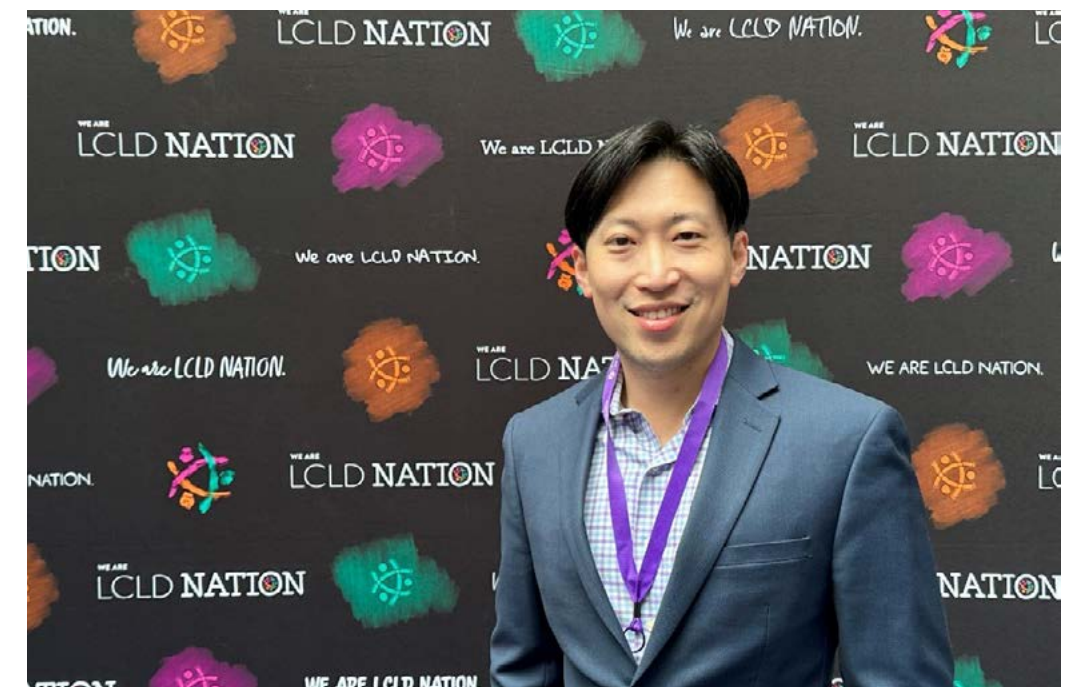

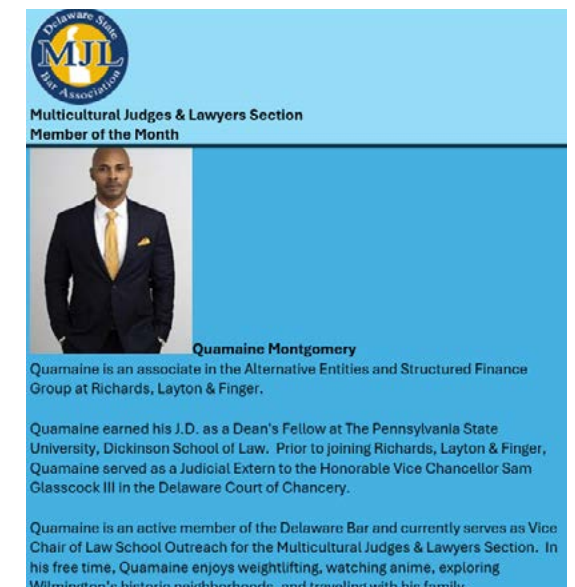
